CMA On-Call is the California Medical Association's 24-hour online health law library for physicians. All documents are available free to members (\$2 per page for nonmembers) at cmanet.org/cma-on-call.

To access the health law library, members should follow these instructions:

Go to www.cmanet.org. In the upper right corner, click on the black box that reads Login.

Enter your username and password. If entering the CMA website for the first time, you will need to register by clicking on the words Activate Web Account at the top of the page.

To register:

- 1) Enter your first and last name to locate your record in our database.
- 2) Click on your name.
- 3) Verify your date of birth, enter your email address (this will be your username), and then select and verify your password (passwords must be at least 6 digits long).

Once you have logged in, the health law library and CMA On-Call documents can be found under Professional Resources.

You can browse the health law library by topic/chapter, or you can search by keyword or document number.

To view the pdf documents, you will need Adobe Acrobat.
