DIRECTORY DEADLINES

- Finished books are delivered in January, 2011.

Terms

COMMISSIONS

National and advertising agency rates are 15% commissionable. Terms: Net 30 days.

No agency commission allowed on accounts outstanding longer than 45 days. No commission is allowed on production costs or miscellaneous and mechanical charges. Camera-ready copy must be provided (minimal pub-set) with written insertion orders. No camera-ready discount available.

ADVERTISING RATE POLICIES

Publisher reserves the right, on 30 days notice, to revise rates on all advertising and contracts.

All display advertisers receiving contract rates must have signed contracts. Contract rates apply only when payment is made in full within 30 days of billing. Invoices not paid within 30 days will be recalculated at the prevailing open rate. Invoices outstanding 90 days or more will automatically cancel contract between publisher and advertiser and the prevailing open rate will be applied to the unpaid advertisements.

SPECIAL SERVICES

- 1 Tearsheets will be provided, if available, to all advertisers. The number will be determined by the nature and need of the business.
- 2 Advertising layout service is available to advertisers.

COPY AND CONTRACT REGULATIONS

- 1 Publisher reserves the right, without giving specific reason, to refuse advertising if copy is not in keeping with publisher's standards.
- 2 Advertisers and advertising agencies assume liability for all content of advertisements printed and also assume responsibility for any claims arising therefrom made against the publisher.
- 3 Advertising simulating editorial content is subject to approval of publisher and will be clearly labeled "advertisement."
- 4 Liability for errors in advertisements will not exceed the cost of the space occupied by the error. Ad proofs are solely for error correction and minor changes. Major revisions will be made at an additional charge of \$20.

- 5 Dates and times for cancellation of ads are the same as the deadlines for placing the ads.
- 6 Advertising is payable in advance unless the advertiser has established credit with Fresno-Madera Medical Society.
- 7 All materials supplied to or produced by Fresno-Madera Medical Society becomes the property of the publisher.
- 8 All political advertising must be paid for in advance and must be labeled "paid advertisement."
- 9 Every effort will be made to meet reasonable position requests. Failure to meet these requests will not constitute cause for adjustment, refund or rerun. An additional charge of 10% is required for special page positions and is not agency commissionable.
- 10 Publisher reserves the right to split double trucks.
- 11 Contracts may be canceled by either party with written notice 30 days preceding publication date. Guaranteed position contracts may not be canceled. Contract rates apply only when payment is made in full within 30 days of billing. Invoices not paid within 30 days will be recalculated at the prevailing open rate. Canceled contracts will be recalculated at the prevailing open rate from the date of the signed contract or the renewing contract date. A separate invoice will be sent to the advertiser labeled "back-billing" for the contracted inches used at the prevailing rate.
- 12 Verbal cancellation must be followed by letter within five (5) working days.
- 13 Acceptance of advertising by any of the publications in no way constitutes approval or endorsement of products or services advertised.
- 14 Terms: Net 30 days from date of invoice. Past due thereafter. Past due accounts will be charged 1.75% finance charge per month (21% per annum).
